I continue to serve as an arbitrator on construction and commercial disputes, from large complex cases to small fast-track cases. My last assignment was to run a Japanese trading company in Tokyo for two years. This was a new entrepreneurial effort for an American owned organization and as such we had to integrate ourselves into the Japanese business system (keiretsu), and build trust with our Japanese and Indian partners. I organized, developed, and lead this new company on a contract that assured uninterrupted funding of US\$1.2 billion (2025\$) for a large power generation and LNG project in India. As the funding was underwritten by the Japanese Bank for International Cooperation (JBIC), coordination was required by our organization between 10 banking partners, dozens of Japanese manufacturing organizations, and numerous private and governmental organizations in Japan, India and globally. Our efforts were successful and recognized as such by GE management.
- In 1998, as Grisham Engineering I provided services, through Granite Professional & Technical Services, for General Electric. I served as the Site Representative for a US\$1.2 billion (2025\$) contract for a portion of a power project in Thailand. Construction. My expertise has been gained on the construction of housing, transportation, manufacturing, and power projects on all continents but Antarctica, and the avoidance/resolution of disputes that arise. Projects range from residential homes to multibillion dollar transportation and power projects. My experience spans from the writing and risk analysis for contracts, through the construction and commissioning, to the close out and resolution of disputes.

ADR. My ADR expertise includes Claim Consultant expert analysis of project schedules, contracts, scope, force majeure, productivity, progress, delays, damages, and responsibility both in preparation of offensives and defenses for mediation and arbitration. Projects included housing, airports, prisons, power, highways, and manufacturing plants. As a consultant I served as a mediator for the resolution of global disputes in multiple countries for a division of General Electric.

Teaching & Writing. For the past two decades I have taught ADR, project management, construction management, contract management, and negotiations at global universities, and for hundreds of global organizations. I have a broad background of publications and speaking engagements on disputes as well.

I have over three decades of experience as an AAA/ICDR arbitrator on dozens of cases. I have served as an arbitrator on panels for large complex domestic (cement plant) and international (residential) construction disputes. I have also served as sole arbitrator on domestic construction for residential, and manufacturing plants disputes. Also, I have served as sole arbitrator for small and fast-track housing disputes, and as sole arbitrator on small fast-track commercial disputes.

I serve as arbitrator on the new AAA/ICDR AI Arbitrator option for construction and commercial disputes. I also have the new ABA TechCred credential first offered in

2025, and am trained and certified in the use of Clearbrief, the AI partner that AAA/ICDR uses. In 2023 I served as Panel Chair in a mock arbitration at the Stetson University. Currently I serve as an arbitration for a mass arbitration case.
